16 DSGVO).



If the legal requirements are met, you can request the deletion or restriction of the processing and lodge an objection against the processing (Art. 17, 18 and 21 DSGVO).

If you have consented to data processing or if there is a data processing agreement and data processing is carried out using automated procedures, you may be entitled to data transferability (Art. 20 DSGVO).

Please address requests for information, the revocation of consents granted or the exercise of your rights to data subjects to the responsible person named under 2. If you make use of the rights mentioned above, the responsible body will check whether the legal requirements for this have been met.

There is also a right of appeal to a supervisory authority. As a rule, you can contact the supervisory authority at your usual place of residence or workplace or at our company headquarters.
